The State Chamber of Oklahoma is dedicated to developing a pro-business climate in Oklahoma. A natural extension of our mission is to financially support pro-business candidates to the state legislature. For this purpose, The State Chamber has created the We Mean Business PAC, a non-partisan political action committee. In the past election, we won 15 of the 16 races we were involved in, with limited PAC funds. This mission is too critical not to substantially increase our PAC fund.

If you would like to help by contributing to The State Chamber of Oklahoma's "We Mean Business" PAC you can send a personal check of any amount up to \$5,000. With your help, The State Chamber of Oklahoma can continue to be your legislative advocate for business.

**PAC FACTS** | The We Mean Business PAC is limited in both the contributions that it can receive (\$5,000 per household) and that it can expend on candidates (\$5,000 per campaign). It is also limited in that it may only solicit contributions from executive and administrative personnel of The State Chamber and of the Chamber's members. The We Mean Business PAC has traditionally only made contributions to candidate committees. The We Mean Business PAC must register and file detailed financial reports of monies raised and expended to the Oklahoma Ethics Commission.
